The O'Brien Foundation (a Charity registered with the ACNC) raises funds to support groundbreaking research conducted by the O'Brien Institute, part of St Vincent's Institute of Medical Research, Melbourne. This research focuses on innovative treatments to restore form and function for individuals suffering from traumatic injuries, cancer (including the after-effects of treatment), and congenital deformities.

Since the 1970s, the O'Brien Institute has been a global pioneer in reconstructive plastic surgery, advancing microsurgical techniques that transformed multi-stage procedures into single-stage operations. Today, researchers are pushing boundaries by moving beyond physical reconstruction to focus on sub-cellular regenerative processes. Through cutting-edge techniques like tissue engineering, stem cell research, and molecular enhancements, the foundation continues Bernard O'Brien's legacy of restoring dignity and hope to patients.

The O'Brien Foundation has raised funds over the years to support research and researchers in the areas of Microsurgery, lymphoedema, lipoedema, tissue generation and heart disease including the effects on the heart from Friedreich's ataxia
